«SNR 30000» forms the new basis for the «TESTEX Community Mask» label

The new Swiss rule «SNR 30000» regarding community masks has been developed by the Swiss

Association for Standardization (SNV) and officially came into force on the 29th of January. The specified

requirements are based on the suggestions of the Swiss National COVID-19 Science Task Force, which

have been acknowledged by the Federal Office of Public Health FOPH. As of February 1st, TESTEX will

therefore test and evaluate all community masks based on «SNR 30000».

In the past few months, the different performance levels of community masks, have been a frequently

discussed topic in the public discourse. As a member of the Swiss Association for Standardization (SNV),

TESTEX and other stakeholders from industry and science, have therefore developed a normative

document that sets minimal requirements for community masks. The Swiss Rule «SNR 30000» includes

basic requirements for splash resistance, breathability, reusability and aerosol filtration efficiency.

As of February 1st 2021, TESTEX will start testing and evaluating all community masks based on the

Swiss Rule «SNR 30000». However, there will be a month-long transition period for all applications

which have been handed in before the publication of the new test criteria.

Compliance with the STANDARD 100 by OEKO-TEX® regulations, remains a valid criteria for the

«TESTEX Community Mask» label.

In order to avoid confusion, every label will state if the recommendations of the Swiss National COVID-

19 Science Task Force or the requirements of Swiss rule «SNR 30000» have been used as a base for

testing. All existing labels remain valid for the intended time frame, but will have to be renewed based

on the requirements of «SNR 30000».
